Dear Administrator Brooks-LaSure,

I write today calling on the Centers for Medicare and Medicaid Services (CMS) to immediately issue regulations or guidance providing full Medicare coverage of all FDA authorized over-the-counter (OTC) at-home rapid tests. Doing so is critical to expanding access to free diagnostic tests, curbing the spread of COVID-19, and protecting Medicare beneficiaries.

I was encouraged to see updated guidance released on January 10, 2022 providing for coverage of up to 32 FDA authorized OTC at-home tests per month by private health insurers and plans. This step was taken, according to the guidance, “to remove financial barriers and expand access to COVID-19 testing.”<sup>[1]</sup> However, despite this welcome move, original Medicare beneficiaries were left out. In FAQs released by CMS, the agency states that “[a]t this time original Medicare cannot pay for at-home tests through this program.”<sup>[2]</sup>

Medicare provides health insurance coverage to over 61 million people, including those 65 and older and people with disabilities, among others.<sup>[3]</sup> In short, this means that Medicare covers some of the most vulnerable individuals in our country, including many who are at highest risk of developing severe COVID-19 infections. They not only need, but deserve, increased access to at-home testing to protect themselves and others.

I continue to request that the administration take all steps necessary to alleviate this shortage and make COVID-19 tests more accessible to all who need them. A critical step in this effort is expanding free coverage of OTC at-home COVID-19 tests to individuals with Medicare coverage. I urgently call on you to take this necessary step.
